### Minimum Criteria for Full Trauma Team Activation

#### **ACS (CD 5-14 & CD 5-15)**

In Level I and II trauma centers, the highest level of activation requires the response of the full trauma team within 15 minutes of arrival of the patient, and the criteria should include physiologic criteria and some or several of the anatomic criteria.”

“In Level III and IV trauma centers, the team must be fully assembled within 30 minutes.”

- Confirmed blood pressure less than 90 mm Hg at any time in adults and age-specific hypotension in children
- Gunshot wounds to the neck, chest, or abdomen
- Glasgow Coma Scale score less than 9 with mechanism attributed to trauma
- Transfer patients from other hospitals receiving blood to maintain vital signs
- Intubated patients transferred from the scene, - OR - Patients who have respiratory compromise or are in need of an emergent airway  
- Includes intubated patients who are transferred from another facility with ongoing respiratory compromise (does not include patients intubated at another facility who are now stable from a respiratory standpoint)
- Emergency physician’s discretion
